RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE URDANETA WASTE MANAGEMENT FOR THE DISPOSAL OF RESIDUAL SOLID WASTES GENERATED BY THE MUNICIPALITY

WHEREAS, the Municipal Government of Moncada is committed to have an efficient, economical and effective solid waste management system and would need a nearer disposal facility to cope with its growing daily waste accumulation in order to save on time and resources;

WHEREAS, by virtue of the foregoing premise, the LGU is eyeing the services of the Urdaneta Waste Management for the hauling and disposal of its residual wastes at the Urdaneta Engineering Sanitary Landfill in Urdaneta City, Pangasinan;

WHEREAS, in view of the foregoing premises, a proposed Memorandum of Agreement was submitted to this August Body, requesting that authority be granted the Local Chief Executive to enter into said disposal agreement for and on behalf of the Municipal Government of Moncada;

WHEREAS, after a thorough perusal of the MOA, the SB finds the same to be of merit;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Health and Environmental Protection, hereby authorizes the Municipal Government of Moncada, through the Honorable Mayor Estelita M. Aquino, to enter into a memorandum of agreement with the Urdaneta Waste Management for the disposal of residual solid wastes generated by the municipality;
