RESOLUTION EXPRESSING SUPPORT FOR AND ENDORSEMENT OF THE PROPOSED ESTABLISHMENT OF AN INTEGRATED SCHOOL SYSTEM IN BARANGAY BAQUERO NORTE IN THE MUNICIPALITY OF MONCADA TO BE KNOWN AS "BAQUERO NORTE INTEGRATED SCHOOL"

WHEREAS, Republic Act 9155 or "Governance of Basic Education Act of 2001" provides that it is the policy of the State to protect and promote the right of all citizens to quality basic education and to make such education accessible to all by providing all Filipino children a free and compulsory education in both elementary and Highschool;

WHEREAS, there is an imperative need to establish an integrated school in Barangay Baquero Norte to deal and cope with the increasing need for quality basic education in the municipality, particularly the contiguous barangays of Banaoang East, Baquero Sur, Camangaan West, Camangaan East and Capaoayan;

WHEREAS, in pursuance of Section 16 of RA 7160 or the Local Government Code, which is the power expressly granted to promote the general welfare of the constituents, the Local Government Unit of Moncada commits itself to strongly support the Department of Education in promoting accessible and quality basic education for learners in Moncada;
