RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A GOVERNMENT TO GOVERNMENT (G2G) AGREEMENT WITH THE MUNICIPAL GOVERNMENT OF PANQUI, TARLAC RELATIVE TO THE PROVISION OF SAFEGUARDS AGAINST DISPOSABLE INFECTIOUS/HAZARDOUS MEDICAL WASTES

WHEREAS, Section 16 of the Republic Act 7160, otherwise known as the "Local Government Code of 1991", provides that local government units shall ensure and promote the general welfare, right to a balanced ecology, health and safety of the people;

WHEREAS, the Municipality of Moncada is committed to improve the health conditions of its constituents and the protection of the environment within its area in compliance with environmental laws, rules and regulations;

WHEREAS, the Municipal Health Office is applying for a License to Operate a Primary Care Facility with the Department of Health and there exists a need for the LGU to enter into an agreement with infectious wastes treater and transporter and Paniqui General Hospital, a health facility operated by the Municipal Government of Paniqui, as the one capable of providing Moncada the necessary services for infectious/hazardous wastes management, treatment transportation and disposal;

WHEREAS, after a careful review and study of the proposed MOA, the SB finds the same to be legal and binding as to form and stipulations therein provided;
