RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH PAYMAYA ENTERPRISE FOR THE ESTABLISHMENT AND USE OF AUTOMATED SYSTEM OF PAYMENT TRANSACTIONS OF LOCAL TAXES, FEES, CHARGES AND OTHER PAYMENT TRANSACTIONS WITH THE MUNICIPAL GOVERNMENT

WHEREAS, under Republic Act No. 11032 otherwise known as the "Ease of Doing Business and Efficient Government Service Delivery Act of 2018" the local government units are mandated to comply and implement a zero-contact policy;

WHEREAS, in accordance with Section 17 of the Local Government Code of 1991, one of the basic services and facilities of the Municipality is to upgrade and modernize tax information and collection services through the use of computer hardware and software and other means;

WHEREAS, Section 2 of Republic Act No. 8792 or the "Electronic Commerce Act of 2000" (E-Commerce Act) which underscores the need to create an information friendly environment which ensures the availability, diversity and affordability of information and communications technology. Section 2 further affirms that the State recognizes the primary responsibility of the private sector in contributing investments and services in telecommunications and information technology;

WHEREAS, Section 27 of the Electronic Commerce Act mandates government offices and agencies to adopt an electronic system of filing and processing;

WHEREAS, the Memorandum of Agreement shall be made in accordance with the Joint Administrative Order No. 02, Series of 2006 of Department of Trade and Industry and Department of Finance entitled "Guidelines Implementing R.A. 8792 on Electronic Payment and Collection System (EPCS) in Government";

WHEREAS, after a careful review and study of the terms and conditions provided in the MOA, the SB finds the electronic payment and collection system beneficial and advantageous to the Municipality of Moncada;

NOW, THEREFORE, premises considered and on motion by Coun. George Michael P. Aguilar, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Trade and Industry, hereby authorizes the Municipal Government of Moncada, through the honorable Mayor Estelita M. Aquino, to enter into a memorandum of agreement with PayMaya Enterprise for the establishment and use of automated system of payment transactions of local taxes, fees, charges and other payment transactions with the municipal government;
