CONFIRMING AND AFFIRMING THE REAPPOINTMENT OF MRS. EMILIA S. QUILET AS MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (MUNICIPAL GENERAL SERVICES OFFICER) OF MONCADA LOCAL GOVERNMENT UNIT

WHEREAS, Section 443 (d) of Republic Act 7160 or the Local Government Code provides that heads of offices and departments in the LGUs shall be appointed by the municipal mayor, unless otherwise provided, with the concurrence of a majority of all members of the Sanggunian, subject to civil service law, rules and regulation. The Sangguniang Bayan shall act on the appointment within fifteen (15) days from the date of its submission; otherwise, the same shall be deemed confirmed;

WHEREAS, Article 20, Section 490 of the same Code provides the minimum Qualification Standards required for the position which states that a Municipal General Services Officer shall be a holder of a college degree on public administration, business administration and management from a recognized college or university, a first-grade civil service eligible or its equivalent and must have acquired three (3) years experience in general services, management of supply, property, solid waste disposal and general sanitation;

WHEREAS, the reappointment of Mrs. Emilia S. Quilet, former Municipal Budget Officer, now Municipal Government Department Head I (Municipal General Services Officer) is in order after having met the minimum requirements provided by law;
