**RESOLUTION GRANTING ONE (1) SACK OF ORGANIC FERTILIZER TO TAXPAYERS AS A FORM OF INCENTIVE FOR EVERY TWO THOUSAND PESO (P 2,000.00) REAL PROPERTY TAX PAID AT THE MUNICIPAL TREASURY**

**WHEREAS**, on February 1, 2001, the Sangguniang Bayan of Moncada passed a Resolution revising to the effect that for every Real Property Tax paid amounting to one thousand five hundred pesos (P1,500.00), taxpayer shall be entitled to a one (1) sack of organic fertilizer as a form of incentive;

**WHEREAS**, given the lapse of time and factors such as inflation and upgrading the schedule of real property assessments, this August Body finds it imperative to revise policies on the grant of such incentive to taxpayers;

**NOW, THEREFORE**, and on motion by Coun. Ruben V. Gamboa, Jr., duly seconded;

**RESOLVED**, that this Sanggunian, acting on the favorable recommendation of the Committee on Agriculture, Land Utilization, Cooperatives and Accreditation, hereby grants one (1) sack of organic fertilizer to taxpayers as a form of incentive for every two thousand peso (P 2,000.00) real property tax paid at the municipal treasury;

**RESOLVED, FURTHER**, that SB Resolution No. 1, Series of 2001 dated February 1, 2001 and other policies, rules or regulations inconsistent herewith are hereby repealed accordingly;
