**RESOLUTION APPROVING AND ADOPTING THE COMPREHENSIVE LOCAL JUVENILE INTERVENTION PLAN FOR CALENDAR YEARS 2024-2026 OF THE MUNICIPALITY OF MONCADA, TARLAC**

**WHEREAS**, Republic Act No. 9344, as amended by Republic Act No. 10630, otherwise known as the "Juvenile Justice and Welfare Act of 2006," mandates local government units to formulate and implement a Comprehensive Local Juvenile Intervention Program (CLJIP) to promote the welfare of children at risk and children in conflict with the law;

**WHEREAS**, the Municipal Government of Moncada, Tarlac, through its Local Council for the Protection of Children (LCPC) and in coordination with relevant stakeholders, has developed the Comprehensive Local Juvenile Intervention Plan (CLJIP) for Calendar Years 2024-2026 to ensure the effective implementation of programs and services addressing juvenile delinquency and child protection;

**WHEREAS**, the CLJIP outlines strategic interventions, including but not limited to prevention, diversion, rehabilitation, and reintegration programs, in alignment with national policies and guidelines;

**WHEREAS**, adopting the CLJIP will strengthen the municipality's commitment to upholding children's rights, ensuring a child-friendly environment, and fostering a responsive and holistic juvenile justice system;
