RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE ESTELITA M. AQUINO, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT FOR THE JOINT PROJECT ENTITLED "MUNICIPAL INNOVATION THROUGH SCIENCE AND TECHNOLOGY" [PROJECT MIST] OF THE DEPARTMENT OF SCIENCE AND TECHNOLOGY, PHILIPPINE INFORMATION AGENCY, PROVINCIAL GOVERNMENT OF TARLAC, TARLAC STATE UNIVERSITY AND LOCAL GOVERNMENT UNITS

WHEREAS, the Department of Science and Technology is mandated by executive Order No. 128 to provide central direction, leadership and coordination of scientific and technological efforts and ensure that the results therefrom are geared and utilized in areas of maximum and social benefits for the people;

WHEREAS, DOST-III/ PSTC-Tarlac, the implementing arm of the Department in the region, is tasked to adopt and carry out science and technology policies, plans, programs and projects, laws, rules, regulations; provide S&T services to the people; and coordinate with other government agencies and with local government units in the region on S&T matters;

WHEREAS, based on Republic Act 7160 (LGC), Local Government Units are mandated to promote and accelerate economic development in their respective jurisdictions which may be achieved through, but not limited to: political commitment, attitude and management capability of LGU's, the market, labor, capital and technology;

WHEREAS, DOST-III has identified the MUNICIPAL INNOVATION THROUGH SCIENCE AND TECHNOLOGY (MIST) as a program that would ensure the effective collaboration between LGUs, LGAs and other stakeholders in development project planning and implementation as well as to establish a network of capacitated and high performing local coordinators as partners in development;

WHEREAS, DOST-III, Provincial Government and Local Government Units of Tarlac, PIA-III and TSU have agreed to work together for the implementation of the said program;

WHEREAS, DOST-III, Provincial Government and Local Government Units of Tarlac, PIA-III and TSU pledge to extend their full cooperation for the effective and efficient implementation of the aforesaid program;

NOW, THEREFORE, premises considered, and on motion by Coun. Thelmaflor A. Espejo, duly seconded:

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Human Resource Development, hereby authorizes the Municipal Government of Moncada, through the Honorable Estelita M. Aquino, Municipal Mayor, to enter into a memorandum of agreement for the joint project entitled "Municipal Innovation Through Science and Technology" [Project MIST] of the Department of Science and Technology, Philippine Information Agency, Provincial Government of Tarlac, Tarlac State University and local government units;
