RESOLUTION NO. 18-2009

On motion by **COUN. MARCLETO U. OBILLO** and unanimously seconded;

RESOLVED, to pass & approve, Resolution No. 18-2009 containing therein Ordinance No. 1 S. 2009, to wit:

**ORDINANCE NO. 1
SERIES 2009**

**“AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 01 S. 1998 WHICH
ORDINANCE SHALL BE KNOWN AS “THE ANTI-LITTERING OF 2009.”**

Section 1. Title.

This ordinance shall be known as **“Anti-Littering Ordinance of 2009.”**

Section 2. Definition of Terms.

- A) Anti-opposite or opposed, against
- B) Littering – disposing of waste in wrong place by unlawful human action. Its ugliness damages the appearance of scenic environment.
- C) Discernment – the act of process of exhibiting keen insight and good judgment; the trait of judging wisely and objectively.

Section 3.

To promote and maintain cleanliness, health and sanitation for the general welfare of the inhabitants, there is a compelling need of the Municipal Government to take positive and effective measures to guard against littering.

Section 4.

It shall be unlawful to strew, litter, dump, or throw garbage, refuse, rubbish, other fifth and domestic waste in any public roads or streets or highways, public places or parks, government buildings and their premises and in any municipal waters and canals.

Section 5.

It shall be unlawful to urinate or to defecate in any public places except in intended urinals and toilets.

Section 6.

Owners of restaurants and other eateries, tricycle operators, sidewalk vendors engaged in business of selling food, retail stores and fishmongers shall provide their own trash cans, or garbage receptacles for their customers. Violation hereof shall constitute a ground for the suspension or revocation of their business license or permits.

Section 7.

Any violations of the ordinance shall be punishable with:

First Offense – Imprisonment of one (1) day or a fine of Five Hundred Pesos (P 500.00) or both or a community service for eight (8) hours at the discretion of the court.

Second Offense- Imprisonment of two (2) days or a fine of Seven Hundred Fifty Pesos (P 750.00) or both or a community service for sixteen (16) hours at the discretion of the court.

Third and Subsequent Offense- Imprisonment of five (5) days or a fine of One Thousand Two Hundred Fifty Pesos (P 1,250.00) or both or a community service for twenty four (24) hours at the discretion of the court.

Section 8.

A person under nine (9) years of age is exempt from any liability for any infraction of the ordinance. Likewise, a person over nine years of age but not under fifteen is exempt from any liability unless he acted with discernment.

Section 9. Repealing Clause

All ordinances inconsistent herewith are deemed repealed.

Section 10. Effectivity Clause.

The ordinance shall take effect after ten (10) days following the completion of its posting at a conspicuous place of the Municipal Building.
