**Section I. Title- “AN ORDINANCE ADOPTING OF AND/OR CONTINUED SUPPORT TO THE NATIONAL HEALTH INSURANCE PROGRAM AND ITS GOVERNING RULES AS SET FORTH IN R.A. 7875.”**

Section II. AUTHORITY AND PURPOSE- As provided for in Article II, Section 15, the Philippine Constitution, it states that the “State shall protect and promote the right to health of the people and to instill health consciousness among them,” and Article XIII, Section II further states that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential good health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged, sick, elderly, disabled, women, and children.

Section III. SCOPE OF APPLICATION- This ordinance shall be adopted by the Municipality in the implementation of the National Health Insurance Program;

Section IV. REPEALING CLAUSE. Any part of this ordinance that is declared null and void shall not have any effect on the entirety of the Ordinance.

Section V. EFFECTIVITY CLAUSE: This Ordinance shall take effect after furnishing copy of the same to the President, Her Excellency GLORIA MACAPAGAL-ARROYO and President/Chief of the Philippine Health Insurance Corporation, HON. FRANCISCO T. DUQUE, III M.D. and the Hon. Provincial Governor, JOSE V. YAP, SR. for their information and the approval of the application for accreditation of the Rural Health Unit of Moncada to the Philippine Health Insurance Corporation.
