**RESOLUTION NO. 69-2008**

On motion by **COUN. EDGARDO I. TOLENTINO** and duly seconded by COUN. MARCLETO U. OBILLO;

RESOLVED, to approve and adopt, as it is hereby approved & adopted, Resolution No. 69 containing therein Ordinance No. 2 as amended, to wit:

**ORDINANCE NO. 2  
S. 2008**

**“AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 3 S. 1999 WHICH  
ORDINANCE SHALL BE KNOWN AS “THE PIGGERY ORDINANCE OF 2008.”**

**BE IT ENACTED BY THE SANGGUNIANG BAYAN OF MONCADA IN SESSION  
ASSEMBLED:**

**SECTION 1.** This ordinance shall be known as **“THE PIGGERY ORDINANCE OF 2008.”**

**SECTION 2.** Definition of Terms:

**Small Scale Piggery** – for purposes of this Ordinance shall mean a hog raising venture usually started in the backyard or the owners domicile, a maximum of four at any given time.

**Medium Scale Piggery-** for purposes of this Ordinance shall mean a hog raising project with a maximum twenty (20) heads and open options for future expansion.

**Built-Up Area** – a community of densely clustered households as in a squatter colony.

### **SECTION 3. General Statutory Provisions.**

Hog raising or any size or magnitude shall be prohibited where project site is located in a built-up area or where households are so close to each other sanitation standards become impossible to maintain.

Small scale piggery projects, shall be allowed where households are fenced in and have adequate space to meet sanitation and structural requirements.

A maximum of four (4) heads shall be allowed where piggery site is not less than fifteen meters away from the nearest households.

Where a maximum of four hogs is intended project site must be fenced in and proper sanitary waste disposal to meet prescribed sanitation and structural standards.

Medium Scale piggery projects shall be allowed only following compliance by hog raisers with specifications provided hereof:

1. A medium scale piggery project shall be not less than thirty meters away from the nearest households.
2. Project site for medium scale piggery must be fenced in with concrete or other non-combustible materials.
3. Piggery wastes shall be contained within project site and not drained outside into public canals and waterways.

Large Scale piggery projects shall be allowed only following compliance by hog raisers with specifications provided hereof:

1. Large Scale piggery projects shall be not less than One Hundred (100) meters away from the nearest households.
2. Large Scale piggery projects shall be fenced in with concrete or other non-combustible materials.
3. Piggery Wastes shall be contained within project compound and not drained outside into public canals and waterways.

Medium and Large Scale Piggery Operators are required to secure an Annual Sanitary Inspection Clearance from a duly authorized Local Government Unit (LGU) agency aside from the Locational Clearance issued by the Municipal Engineer's Office before start of operations.

**Piglets may not be counted as head if they are below 50-days old.**

### **SECTION 4. Penalty Provisions.**

Medium Scale and Large Scale Piggery Operators found in violating of the provisions of this ordinance shall be fined P2,500.00 and revocation of their Business Permit after ignoring a second written notice and warning from the Local Government Unit.

### **SECTION 5. Effectivity Clause.**

This ordinance shall take effect at the end of the period of Thirty (3) days of its posting at the Bulletin Board of the Municipal Hall and every Barangay Hall in the municipality.

RESOLVED FINALLY, that copies of this Resolution be furnished all the Barangay Captains of the municipality for their information and guidance.
