RESOLUTION NO. 79

On motion by Coun. CLEOFE D. FAVIS & unanimously seconded;

RESOLVED, to pass & approve, Resolution No. 57 containing therein ordinance no. 2, to wit:

**ORDINANCE No. 2
Series of 1996**

“AN ORDINANCE REGULATING FARM IMPLEMENTS PARTICULARLY “KULIGLIG” FROM USING OR TRAVELLING ALONG THE NATIONAL HIGHWAY”

BE IT ENACTED BY THE MUNICIPAL COUNCIL OF MONCADA, TARLAC IN SESSION ASSEMBLED:

-THAT-

Section 1. Regulatory Provisions – No person driving the farm implement “Kuliglig” shall be allowed to use or travel along the National Highway within the jurisdiction of this municipality unless they can provide their safety warning devices like reflectors, head, tail & stop lights and brakes and likewise, no person under the influence of liquor shall be allowed to drive.

That the age requirement for the driver/operator of “Kuliglig” should be 18 years old and above & they should be physically fit to drive.

Section 2. Definition of Terms:

- a) National Highway – this is the main portion of the National Highway.
- b) “Kuliglig” – farm machinery/implement convened to transport goods from farm-to-market.

Section 3. For the effective implementation of this ordinance, the Barangay Officials shall be deputized to monitor conformity of the above-stated conveyances.

Section 4. Penalty Clause – Violation of any provision of this ordinance shall be punishable by impounding the implement under the custodial care of the barangay where the same was intercepted & could be released only upon paying corresponding impounding fee of P 300.00 or if it causes accident, the owner of the implement shall be held liable to any damage it caused.

Section 5. All ordinance, rules & regulations or part thereof whose provisions are in conflict with or contrary with the provisions of this ordinance are hereby repealed, amended or modified accordingly.

Section 6. This ordinance shall take effect 60 days upon approval.
