**RESOLUTION NO. 97-2002**

On motion presented by COUN. ALBERTO F. MORALES and unanimously seconded;

RESOLVED, to amend, as it is hereby amended, certain provisions of Resolution No. 63-2002 containing therein Ordinance No. 2 S. 2002, to wit:

**ORDINANCE No. 2  
SERIES 2002**

**“AN ORDINANCE PRESCRIBING A UNIFORM COLOR SCHEME FOR PUBLIC  
UTILITY TRICYCLES IN MONCADA”**

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF MONCADA,  
TARLAC**

-THAT-

Section 1. Title. That this ordinance shall be known as “**MOTORIZED TRICYCLE COLOR CODING ORDINANCE OF 2002.**”

Section 4. REQUIREMENT. All owners or operators of tricycles before they operate are required to paint the sidecar entirely with CRYSTAL GREEN with the corresponding number prominently painted in WHITE both at the front and back sides of the sidecar and the name of the Barangay painted below the number. That the size of the number shall be 7 inches in height and 30 cms. in width.

Section 5. All owners or franchise operators of tricycles are given until December 31, 2002 to comply with the provision of the next preceding section.

Section 7. PENALTY. Any owner or operator of tricycles found violating any of the provisions of the ordinance shall pay a fine of P100.00 for the first offense; P300.00 for the second offense; and P500.00 for the third offense including the revocation of their Mayor's Permit

This ordinance shall take effect upon its approval.
