**RESOLUTION NO. 49**

On motion presented by Coun. ALBERTO F. MORALES & duly seconded;

RESOLVED, to pass & approve, as it is hereby passed and approved, Resolution No. 49 s. 1998 containing therein ordinance no. 3, to wit:

**ORDINANCE No. 3**

**“AN ORDINANCE REQUIRING MOBILE/ROBING RICE, CORN & CEREAL MILLS (KISKISAN) TO SECURE A MAYOR’S/ BUSINESS PERMIT BEFORE DOING BUSINESS WITHIN THE JURISDICTION OF MONCADA, TARLAC”**

**BE IT ENACTED BY THE SANGGUNINANG BAYAN MEMBERS IN SESSION ASSEMBLED:**

-THAT-

Statutory Provisions:

Section 1- All Mobile/ Roving Rice, Corn & Cereal Mills (Kiskisan) doing business in the Municipality of Moncada are hereby required to secure a Mayor’s/Business Permit;

Section 2- The Mayor’s/Business Permit shall be issued only upon:

- a) Filing & approval of formal applications;
- b) Payment of application fee in the amount of P 1,700.00/annum; and
- c) Submission of clearance to the Municipal Treasurer that basic license is paid.

Section 3- Mobile/Roving Rice, Corn & Cereal Mills (Kiskisan) used for business within Moncada without the necessary Mayor’s/Business Permit shall be impounded by

authorized deputies and shall not be released until payment of the corresponding fee is made thereafter.

Section 4- An impounding fee of P 50.00/day shall be collected from the operator/manager of Mobile/Roving Rice, Corn & Cereal Mills (Kiskisan) for failure to secure the necessary Mayor's/Business Permit.

Section 5- Any ordinance or any provisions hereof which is inconsistent herewith are hereby repealed and/or accordingly modified.

Section 6- This ordinance shall take effect immediately upon approval.
