**RESOLUTION NO. 56**

On motion by Coun. ZOSINO B. CUCHAPIN and duly seconded by Coun. CATALINO C. AGANAN, JR.

RESOLVED, to pass & approve, Resolution No. 56 s. 1999 containing therein Ordinance No.3, to wit:

**ORDINANCE No. 3**  
**s. 1999**

**“AN ORDINANCE REGULATING HOG RAISING IN SPECIFIC AREAS IN THE COMMUNITY ACCORDING TO STANDARD SANITARY REQUIREMENTS AND PRESCRIPTIONS AS TO SIZE AND NUMBER AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF”**

**BE IT ENACTED BY THE MEMBERS OF THE SANGGUNINANG BAYAN IN SESSION ASSEMBLED:**

**-THAT-**

Section 1. This ordinance shall be known as the Scale Piggery Project of 1999.

Section 2. For purposes of this ordinance, Small Scale Piggery Project is limited to Six (6) heads, Medium Scale Piggery Project is limited to Twenty (20) heads or less, and Large Scale Piggery Project is composed of more than Twenty (20) heads. However, piglets may not be counted as heads if they are below fifty (50) days old.

Section 3. That every person in the community shall have the right to the full enjoyment of life and to live in a wholesome environment and atmosphere.

Section 4. Every person in the exercise of the rights to engage in business or trade must give everyone his due, observe good faith and act with reasonable restraint in order not to violate the rights of others.

Section 5. Hog raisers engaged in Small, Medium or Large Scale Piggery Projects shall keep the premises in clean and sanitary conditions. That it shall be mandatory to adopt measure designed to lessen foul odor, like providing enough pits or receptacles, one to be used for the fresh waste and another to be for the dried waste of the hogs. That the owner shall use applicable substances, chemicals or compounds on the waste in order to neutralize any abnoxious smell.

Section 6. All medium and Large Scale Piggery Projects shall, in the case of the former, be located 40 meters away from the residential areas, and 500 meters away in the case of the latter, However, if the required distance is not complied with, approval of the Sangguniang Barangay concerned through a Council Resolution is required.

Section 7. Any person who may suffer discomfort due to the unremitting offensive smell of the hog manure may file an action against the owner for the closure of the Piggery Project or the imposition of a fine of not more than ₱ 2,500.00 or both at the discretion of the court.

Section 8. Any person desiring to engage in the business of Medium or Large Scale Piggery Project shall first secure a Barangay Clearance, Sanitary Permit and Mayor's Permit before embarking into the venture.

Section 9. That the Municipal Health Officer and the Punong Barangay concerned or their authorized representatives are empowered to inspect from time to time, the piggery establishments and may recommend to the Chief Executive for its closure or revocation of the Mayor's Permit if any, is found to be violating the provisions of Section 5 and 6 of this ordinance.

Section 10. Any hog raisers committing any violation of this ordinance shall be punished with a fine not exceeding ₱ 2,500.00 and the revocation of the Mayor's Permit.

Section 11. This ordinance shall take effect at the end of the period of Thirty (30) days of its posting at the Bulletin Board of the Municipal Hall and every Barangay Hall in the municipality.
