RESOLVED, to pass & approve, Resolution No. 63-2006 containing therein Ordinance No. 3, S. 2006, to wit:

**ORDINANCE NO. 3
SERIES 2006**

“AN ORDINANCE BANNING FISH HOLE DIGGINGS AND THE CONSTRUCTION OF STRUCTURES WHICH EMPEDE THE FLOW OF WATER IN RIVERS AND WATERWAYS OF PUBLIC DOMAIN.”

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF MONCADA, TARLAC IN SESSION ASSEMBLED:

- T H A T -

Preamble: It is the general policy of the LGU of Moncada to preserve and protect the natural resources of the locality to the full benefit of the people.

Section I. Title.

This ordinance shall be known as “**THE FISH HOLE ORDINANCE OF 2006.**”

Section II. Definition of Terms:

- A. Fish Hole- an excavation in rivers and waterways which serves as a fish trap as water recedes or as the river dries.
- B. Public Domain- natural or man-made resources which are under the control; direct supervision, protection and administrative care of the state as distinguished from private property.

Section III. Statutory Provisions:

- A. Fish Hole diggings which impede the free flow of water in rivers and waterways of public domain shall be prohibited under this ordinance.
- B. Construction of temporary or permanent structures in rivers and waterways such as floodgates, fish traps, dams or even human abode shall be prohibited.

Section IV. Penalty Provisions:

Any person found violating any provisions of this Ordinance shall be fined: P1,500.00. However, in case the offenders can not pay the amount of P1,500.00, he shall render a community service of 5-days on an 8-hour a day basis.

Section V. Effectivity.

This ordinance shall take effect immediately upon approval.
