RESOLUTION NO. 41

WHEREAS, the Municipal Government, saddled as it were limited resources and financial constraints, cannot possibly pursue with greater facility its development programs under existing conditions;

WHEREAS, the continuing effort of the government to meet revenue levels that would support and sustain its development thrust would now necessitate a more comprehensive and exhaustive review of its resource management and revenue collection policies;

WHEREAS, a good number of private individuals are now engaged in contractual work without the necessary Permits for them to lawfully pursue their vocation without prejudice to other professional groups that have legal personalities of their own;

WHEREAS, to protect and preserve the public good from unscrupulous individuals moonlighting as Professional Contractors and subsequently earn additional revenue for the Local Government Unit;

RESOLVED, to pass and approve, as it is hereby passed & approved, Ordinance No. 4, s. 1995, to wit:

**ORDINANCE No. 4
S. 1995**

“AN ORDINANCE REQUIRING INDIVIDUALS OR GROUPS OF INDIVIDUALS ENGAGED IN CONTRACTUAL WORK OR SIMILAR VOCATIONS TO REGISTER AS SUCH WITH THE MUNICIPAL GOVERNMENT AND SECURE THE CORRESPONDING MAYOR’S PERMIT / LICENSE THEREOF”

BE IT ORDAINED BY THE MUNICIPAL COUNCIL IN SESSION ASSEMBLED:

-THAT-

Section 1 – Definition of Terms:

A. Contractual Work – refers to a vocation engaged in by persons by way of an explicit agreement with other persons to render specific services for a fee within an agreed specified period of time.

A.1 Contractual Work would include: Deep or Shallow Well Installations, Building Construction, Installation of Electrical System, Masons, Steelman, Plumbers, House Painters, Marble Setters, and the like.
