RESOLUTION NO. 51

On motion by Kgd. ALBERTO F. MORALES & unanimously seconded;

RESOLVED, to pass & approve, as it is hereby passed and approved, Resolution No. 51 containing therein ordinance no. 5, to wit:

ORDINANCE No. 5

**“AN ORDINANCE IMPOSING STORAGE FEES ON VEHICLES INVOLVED IN
VEHICULAR ACCIDENTS AND ON ALL OTHER IMPOUNDED VEHICLES”**

**BE IT ENACTED BY THE SANGGUNINANG BAYAN MEMBERS IN SESSION
ASSEMBLED:**

-THAT-

Section 1. Statutory Provisions:

Motor Vehicles involved in vehicular accidents and all other impounded vehicles within the premises of the Municipal Building shall be subject to Storage Fees.

Section II. Definition of Terms:

II.a Storage Fees – the cost of storing goods

II.b Motor Vehicles – all types of vehicles meant for travelling on streets or roads.

II.c Impounded Vehicles – vehicles taken into legal custody.

Provided, however, that impounded vehicles within the premises of the Municipal Building would be at the risk of the owners.

Section III. Penalty Clause:

- 1) Motor Vehicles impounded within the premises of the Municipal Building after 24 hours shall be charged a Storage Fee of ₱ 50.00 per day to be collected by the Municipal Treasurer or her authorized representative/s with a corresponding Official Receipt.
- 2) Motor Vehicles impounded within the premises of the Municipal Building but claimed within 12 hours shall be exempted.

Section IV. This ordinance shall take effect upon its approval.
