RESOLUTION NO. 61

On motion by Kgd. CLEOFE D. FAVIS & unanimously seconded;

RESOLVED, to pass & approve, as it is hereby passed and approved, Resolution No. 61 s. 1997 containing therein ordinance no. 6, to wit:

ORDINANCE No. 6

**“AN ORDINANCE REQUIRING TRANSIENT MERCHANTS AND TRADERS PLYING
THEIR TRADE INSIDE THE PUBLIC MARKET OR ANYWHERE ELSE WITHIN THE
MUNICIPALITY, TO SECURE A MAYOR’S PERMIT FOR THEIR BUSINESS”**

**BE IT ENACTED BY THE SANGGUNINANG BAYAN MEMBERS IN SESSION
ASSEMBLED:**

Statutory Provisions:

This act shall regulate the practice of transient traders and merchants doing business inside the Public Market or elsewhere within the Municipality by requiring them to secure a Mayor’s Permit for that purpose to protect those who are duly registered and other legitimate traders and merchants from undue competition.

Section 1. It shall be unlawful for transient retailers or wholesalers of economic goods to ply their trade inside the Public Market or anywhere else within the Municipality of Moncada.

Provided, however, that they can secure the necessary permit and other pertinent requirements relevant to their legal operation.

Section II. Definition of Terms:

II.a Transient Merchant or Trader – anyone engaged in the retail or wholesale of economic goods who is always on the road without establishing a permanent or long-term right to a market space where he could sell his/her goods.

Section III. Penalty Provisions:

Violation of this Municipal Ordinance shall cause the arrest and detention of offenders, the confiscation of economic commodities being peddled and the impounding of vehicles used in their trade provided, however, that offenders pay a fine of ₱ 300.00,

Provided further, that an impounding fee as provided for in existing ordinances be paid also.

Section IV. Barangay Officials and other authorized persons or representatives are hereby empowered to implement this ordinance according to its provisions in their own localities where transient traders and merchants happen to ply their trade.

This municipal ordinance shall take effect immediately upon approval of the Municipal Mayor and concurrence of the Provincial Board.
