**RESOLUTION PRESCRIBING A TEMPORARY SCHEDULE OF ADJUSTED TRICYCLE FARES IN THE MUNICIPALITY OF MONCADA DURING THE PERIOD OF GENERAL COMMUNITY QUARANTINE AMID THE COVID-19 PANDEMIC**

WHEREAS, after Tarlac province was placed under GCQ from ECQ status, public transportation was allowed to operate at a reduced operational and vehicle capacity in areas so declared, following the Omnibus Guidelines for Community Quarantine;

WHEREAS, the foregoing circumstances could pose potential economic loss to tricycle operators due to their reduced operational capacity allowing only one (1) passenger to board tricycles;

WHEREAS, in view thereof, the temporary fare adjustment is hereby recommended by the Municipal Tricycle Franchising and Regulatory Board (MTFRB) and the Municipal Task Force against COVID-19 (MTF Covid-19);

NOW, THEREFORE, premises considered, and on motion by Coun. Celeste A. Ayson, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Transportation and Public Utilities hereby prescribes a temporary schedule of adjusted tricycle fares in the Municipality of Moncada during the period of general community quarantine amid the Covid-19 pandemic, to wit:

RESOLVED, FURTHER, that the following guidelines shall be observed by all Tricycle Operators and Drivers Association operating in Moncada:

1. Tricycle operators shall comply with the statutory and regulatory requirements of the MLGU such as MTOP, Mayor's Permit, Driver's License and vehicle registration and receipts.

2. This fare matrix shall be effective from May 18 to 31, 2020 and may be further extended depending on the status of Community Quarantine in the province. Such extension of fare schedule may be imposed through an Executive Order from the Municipal Mayor.
3. Persons below 21 and 60 years old and above shall not be permitted to board tricycles-for-hire, EXCEPT for indispensable reasons or in cases where these persons are considered Authorized Persons Outside Residence (APORs).
4. The fare matrix is for one-way route only going to town proper.
5. One (1) driver and one (1) passenger per tricycle only. Violators may be penalized or arrested by persons in authority. Exemptions shall be granted for emergency situations only.
6. TODAs must follow the prescribed MARKET SCHEDULE for their operation. The DOTr and IATF have issued guidelines that public transportations may only operate at a "reduced capacity".
7. Tricycles must be installed with PLASTIC BARRIER between the driver and passenger for protection against Covid-19.
8. Social distancing and wearing of FACE MASK MUST be strictly observed. Violators shall be fined P2,500.00 pursuant to Municipal Ordinance No. 02-2020.
9. Frequent use of sanitizer, alcohol and disinfectants is highly encouraged.
10. Tricycles shall only use the outermost lane of highways and shall, at all times, observe traffic laws, rules and regulations, including loading and unloading of passengers at designated drop-off points.
11. Special permit shall be granted to Tricycle operators that transport passengers and goods outside the municipality.

RESOLVED, FURTHERMORE, that copies of this Resolution be furnished all concerned agencies and offices for their information and shall be posted in the LGU's social media platforms, website and in at least three (3) conspicuous places in the municipality for public information and widest dissemination;
