RESOLUTION AUTHORIZING SUPPLEMENTAL BUDGET NUMBER 2 FOR THE GRANT OF HAZARD PAY TO LGU PERSONNEL WHO PHYSICALLY REPORTED FOR WORK FROM MAY 1 TO 15, 2020 PURSUANT TO ADMINISTRATIVE ORDER NO. 26, SERIES OF 2020 AND THE GRANT OF PERFORMANCE-BASED BONUS TO OFFICIALS AND EMPLOYEES OF THE MUNICIPAL GOVERNMENT OF MONCADA FOR FISCAL YEAR 2019 PURSUANT TO DILG-DBM JOINT MEMORANDUM CIRCULAR NUMBER 2019-01

WHEREAS, in view of the COVID-19 pandemic, President Rodrigo R. Duterte issued Administrative Order No. 26 on March 23, 2020, granting hazard pay to government employees who physically report for work during the Enhanced Community Quarantine;

WHEREAS, DILG-DBM Joint Memorandum Circular No. 2019-01 provides guidelines on the grant of the Performance-Based Bonus (PBB) for officials and employees of LGUs for FY 2019;

WHEREAS, the LGU of Moncada has satisfactorily complied with all the preconditions to become eligible to the grant of PBB for FY 2019;

WHEREAS, under Section 4 of Moncada Appropriation Ordinance No. 02, Series of 2019, the Mayor and the Presiding Officer are authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations;




