WHEREAS, private individuals seeking redress for improprieties or for any other offenses as enumerated in the Local Government Code committed against them by public officials themselves is a relief offered under the Code as a deterrent to the abuse of vested authority in violation of the code of conduct among said officials;

WHEREAS, the Sangguniang Bayan, by virtue of its quasi-judicial functions, is empowered under the Local Government Code to conduct investigations and render decisions thereof relating to administrative cases;

WHEREAS, in instant administrative case, the Sangguniang Bayan, sitting *En Banc* as an investigative panel, strongly believes that complainant Daisy P. Anciro has established strong connection between her allegation and the charges hurled against respondent Ms. Josefa D. Tacdol, Barangay Kagawad of Calamay, this Municipality;

WHEREAS, under the circumstances, the SB, by a unanimous vote, finds that respondent Tacdol, based on narration of facts and presentation of evidences, committed acts constitutive of abuse of authority and grave misconduct, thus, charges filed before this Honorable Body do merit the penalty of suspension from the service for sixty (60) calendar days without pay;

NOW, THEREFORE, premises considered and on motion unanimously presented and approved;

RESOLVED, that the Sangguniang Bayan *En Banc*, acting on the instant administrative case, hereby finds Respondent Josefa D. Tacdol **GUILTY** of Abuse of Authority and shall be meted the penalty of **SUSPENSION** from the service for sixty (60) calendar days from receipt of this Resolution;

RESOLVED FURTHER, that copies of this DECISION be furnished both parties, the Honorable Mayor Estelita M. Aquino, the MLGOO, the LnB President, and all concerned parties for their information;
