RESOLUTION AUTHORIZING THE DISBURSEMENT AND TRANSFER OF LGU PHILHEALTH COMMISSION FROM THE ACCRUAL OF SHARE FROM THE COLLECTION OF PHILHEALTH PREMIUM CONTRIBUTIONS AT THE MUNICIPAL TREASURY

WHEREAS, the establishment of Philippine Health Insurance Corporation (PhilHealth) aims to give Filipinos a mechanism to gain financial access to health services. Towards this end, the government corporation maintains an efficient premium collection mechanism, and engages the services of accredited collecting agents to enable its members to pay their premium contributions;

WHEREAS, for convenience, accessibility and proximity of the paying public, PhilHealth has entered into a Collection and Remittance Agreement (CRA) with the Local Government Unit of Moncada and designated the same as PhilHealth Collecting Agent (PCA) for premium contributions of its members;

WHEREAS, under the terms and conditions of the agreement, the LGU is entitled to forty pesos (P40.00) share per payment transaction with PhilHealth members;

WHEREAS, cognizant of the additional income earned by the LGU through the foregoing partnership and as a token for their effort, the designated collecting officers are hereby given incentive from the LGU's commission;

NOW, THEREFORE, premises considered, and on motion by Coun. Cleofe D. Favis, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Finance, Ways and Means and Appropriations, hereby authorizes the disbursement and transfer of LGU PhilHealth commission from the accrual of share from the collection of PhilHealth premium contributions at the municipal treasury, to wit:

- 1) The fifty percent (50%) of commission shall be transferred from the Special Account to the General Fund of the Municipal Government of Moncada;
- 2) The remaining fifty percent (50%) of commission shall be distributed to the collecting officers in-charge of the collection, reporting and remittance of premium contributions from PhilHealth members;
- 3) The disbursement and transfer of funds shall be subject to the usual accounting and auditing rules and regulations;

RESOLVED, FURTHER, that copies of this Resolution be furnished the Municipal Mayor and Municipal Treasurer, and all concerned parties for their appropriate action;
