RESOLUTION ENDORING PRIORITY PROGRAMS, PROJECTS AND ACTIVITIES TO BE FUNDED FROM THE LOCAL GOVERNMENT SUPPORT FUND - COVID-19 FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS PURSUANT TO BAYANIHAN TO RECOVER AS ONE ACT OR REPUBLIC ACT 11494

WHEREAS, a Department of Budget and Management Local Budget Circular No. 128 issued September 17, 2020 promulgates guidelines on the release and utilization of the Local Government Support Fund - COVID-19 Financial Assistance to LGUs pursuant to Bayanihan to Recover as One Act or RA 11494;

WHEREAS, said financial assistance is intended solely for COVID-19 related programs, projects and activities;

WHEREAS, the LGU of Moncada has identified COVID-19 priority programs, projects and activities (PPAs) to avert and control the spread of the dreaded disease;

WHEREAS, the Committee on Health and Social Services, jointly with the Committee on Finance, Ways and Means and Appropriations favorably affirm the endorsement of the said priority PPAs;

NOW, THEREFORE, premises considered, and on motion by Coun. Cleofe D. Favis and unanimously seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Health and Social Services and Committee on Finance, Ways and Means and Appropriations, hereby endorses COVID-19 related programs, projects and activities to be funded from the Local Government Support Fund – COVID-19 Financial Assistance to LGUs, specified in particular order of priority, to wit:

1. Procurement of Motor Vehicle
 - a. Emergency Medical Service Vehicle - P 1,300,000.00
 - b. Patient Transport Vehicle - P 1,600,000.00
2. Procurement of Xray Digital Imaging - P 1,380,000.00
3. Procurement of COVID-19 Response Items
(Medicines, Vitamins, Lab Supplies,
Testing Kits, PPEs) - P 4,284,329.52
4. Improvement of Existing Evacuation Center - P 3,070,000.00
As a COVID-19 Isolation Facility for PUIs
